1. Obtain a free Statutory Right of Occupancy (R of O) application form from: Desk Officer,

Leave NO section empty orunanswered.

2. Applicants are required to attach the following Documents:

- One Passport-sized Photograph
- Any valid means of Identification (Valid Driver's License, Voter's Card, National ID, International Passport)
- Land Transfer Documents such as Sales Agreements, Deed of Transfer or Inheritance Documents.
- Sketch Plan (Obtainable from the Surveyor General's Office or a Licensed Surveyor).
- Evidence of Current Tax Clearance Certificate and Certificate of Incorporationfor corporate organizations and individuals obtainable from https://ktirs.com/invoice.
- Utility Bill or endorsement from District/Village Head.
- Evidence of payment (printed bank teller) of non-refundable application processing fee of N20,000.00 for corporate and N15,000.00 for individuals through Zenith Bank Account Number 0777515446 or First Bank Account Number 2014382486.
- 3. Duly completed application form, as in (2) above, will be submitted online or to the Desk Officer, Katsina State Ministry of Lands and Physical Planning along with evidence of payment.
- 4. The Applicant will be invited for a joint site inspection within 3 working days of submission of the application form via Telephone and or Email.
- 5. All applicants will receive a response within 5 working days from the date of joint site inspection via Telephone and or Email.
- 6. Successful Applicant will receive an Offer of Right of Occupancy, an Invoice for the final Bill (Ground Rent, Premium and Development Levy), and a copy of

 (6) and a signed copy of the acceptance Letter should be returned to the Desk Officer.
- 8. Preparation, execution and registration of Certificate of Occupancy will be concluded within 4 weeks.
- 9. Successful Applicants will be notified by phone or mail for collection of the Certificate of Occupancy (C of O) which would be issued by the Desk Officer Lands,Katsina State Ministry of Lands and Physical Planning 07041187817 at info@mols.kt.gov.ng.
