

STEPS FOR REDRESS MECHANISM:

STAGE	ACTION	RESPONSIBLE PARTY	TIMEFRAME
Submission of Grievance:	Citizens can submit their grievances in writing to the designated authority of the Urban and Regional Planning Board.	Grievant (Traders)	Within 5 days
Acknowledgment:	The board acknowledges receipt of the grievance and provides a reference number for tracking purposes.	Grievance Redressal Officer	Within 2 business days upon receiving of the grievance
Preliminary Review:	The board conducts a preliminary review of the grievance to assess its validity and relevance to urban and regional planning matters.	Grievance Redressal Team	Within 5 days

Formal	If deemed necessary, a formal	Grievance	Within 5 days
Investigation:	investigation is initiated to gather more information and assess the impact of the grievance on planning decisions.	Redressal Team	
Consultation:	The team may consult with relevant stakeholders, experts, or community representatives to gather diverse perspectives on the grievance.	Grievance Redressal Team	Within 5 days
Decision and	Based on the findings, the Team	Grievance	Within 5 days
Resolution:	makes a decision and communicates the resolution to the concerned parties.	Redressal Team and Concern Party	
Appeal Process:	A transparent appeal process is established for individuals dissatisfied with the initial resolution. This may involve a higher-level review or an independent body.	Appellate Authority	Within 10 days of resolution communication
Feedback	The GRM should include a feedback	Grievant (Traders)	Within 10 days
Mechanism:	mechanism for citizens to provide comments on the grievance handling process, ensuring continuous improvement.		of resolution communication
