BE IT ENACTED by the House of Assembly of Katsina State of Enactment Nigeria as follows:

- This Law may be cited as the Katsina State Appropriation Law, Short title 1. 2025.
- 2. This Law shall come into operation on the 184 day of Commencemen to 2025.
- The Accountant-General of Katsina State may on the warrant Expenditure of the Commissioner of Finance, issue from the Consolidated Revenue Fund of Katsina State during the year ending 31st day of December, 2025, any sum not exceeding the sum of Six Hundred and Ninety-Two Billion, Two Hundred and Forty-Four Million, Four Hundred and Forty-Nine Thousand, Five Hundred and Thirteen Naira, Eighty-Seven Kobo Only (N692,244,449,513.87)

of the sum of N692,244,449, 513.87

The sum mentioned in Section 3 of this Law shall be appropriated for the purpose and in the manner expressed in the Schedule
